1. The following non-refundable investments are required :

2. Method of Payment :

- 2.1. Payments for the capital and registration fee are due during enrolment.
- 2.2. Payment for the first month's tuition fee, book fee, art, insurance, sundries and stationery, etc. must be paid by the first week of the new school year.
- 2.3. Parents will be billed during the last week of every month for tuition fees for the following month – payable in advance. Payment must be done no later than the fifth of the month.
- 2.4. 5% discount is offered to all parents who pay the annual tuition fees in advance. The payment must be done by the first week of the new school year.
- 2.5. A late fee of 50,000 Ariary will be added to the tuition if payments are late and/or after the tenth of the month.
- 2.6. Please pay via debit order not postdated cheques.

3. Loss or Damage to Property :

Should a student be found responsible for the loss of or damage to property of the school or any other party, whether accidentally or deliberately, the parent/sponsor shall be held liable for payment or replacement of said property.

4. Non-refundable policy:

All payment received in advance will not be refunded if the child is removed from school.
